ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and [procedural] Regulations, National Council for Teacher Education [Recognition Norms and PrRegulations, 2014 on 2009, the National Council for Teacher Education has notified the 1.12.2014.

2. AND WHEREAS, the institution, **Vijayanagara College of Education, Vidyanagar, Hubli - 580031**, Karnataka has by affidavit consented to come under New Regulations and sought for one unit in **M.Ed**, which requires additional facilities

3. AND WHEREAS, it has been decided to permit the institution an **intake of one unit of 50 students** subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional infrastructure, (b) additional funds, (c) additional staff as per regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved staff list in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

4. Now therefore, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Vijayanagara College of Education, Vidyanagar, Hubli - 580031**, Karnataka for conducting M.Ed programme of two years duration with an annual intake of 100 students (two unit) from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31.10.2015.

5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.


7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmes;
- b) Name of faculty and staffs along with annual intake in the institution: qualifications, scale of pay in full as mentioned in school certificate along with their
- c) Name of faculty members and photograph.
- d) Names of Students who left or joined during the last quarter: Percentage of marks obtained during the current session along with qualification, date of admission, etc.; the qualifying examination and in the entrance test, if any,
- e) Fee charged from student
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure
- j) The institution shall be free submitted along with application.
- k) Any false or incomplete information to post additional relevant information. If it so desires, withdrawal of recognition information on website shall render the institution liable for

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 7(1) of the NCTE Act.
